### General Admin/Ball Hockey | Presenter Scott Nelson – President

- i) Call to Order.
- ii) Previous Meeting Minutes approved.
- iii) KVMHA Ball Hockey League Change in Policy regarding Referee Pay Scale. Referees will receive pay on par with other associations. However, any referee who agrees to referee a game on short notice will receive an extra \$5.00 per hour.
- iv) Financial Report Scott reporting in absentia of Geoff Cochrane. KVMHA has a surplus of \$55,057. Estimating revenue is challenging due to cost predication indicators can fluctuate, i.e. registration numbers, tournament profits, etc. Tournaments are good revenue generators. We did stay very close to our operational cost predictions. Motion put forth to approve the financial report passed unanimously. This will be shown to members at the AGM.
- v) Ball Hockey Minutes Approved by the Board unanimously. Members can see the Ball Hockey meeting minutes which are posted on our KVMHA website.
- vi) May 13 start to the Ball Hockey Season. Balancing will start the season and all equipment has arrived for the teams.

- i) Christina Ebbett, our registrar, did a great job compiling the data inputted by the members.
- ii) Some comments from members are concerning because they seem to be intended to insult the Board rather than to inform. The numerical results were more favourable than the comments. This data and some of the more "tailored' comments provided useful criticism that the Board will take seriously and attempt some improvements.

- iv) Motion put forth to create an information sheet answering the most "Frequently Asked Questions". This will be placed on the website. Motion passed unanimously.

### Changes to our Ice Allocation | Presenter – Glenn Piercy – Director of Revenue

 The Town of Quispamsis has made it more difficult for KVMHA to obtain enough Ice-Time to support it players and their development. This has been a growing struggle for a few years now. This leaves the Board the only option to attend a Council Meeting to express our concerns and to push for a more equitable solution to having ice at a more reasonable cost and more accessible.
